



## Business stall holder - Conditions

---

**Stall hire:** Stall hire fee paid includes GST, your stall (table & chair), and space for large items in our dedicated large items display area. By paying the stallholders fee, you have read the charges and conditions of the Baby & Kids Market and agreed to them.

**Advertising, promotional materials, flyers, etc:** All stallholders may hand out advertising or promotional material at their designated stall. The advertising/promotional material may only relate to the product/service on sale at that stall. Stall holders and their representatives are at no time permitted to distribute advertising or promotional material outside of their stall area (i.e. walking around the venue and handing out flyers, etc). A breach of this condition will result in the stall holder being requested to leave the venue.

**Floors:** When carrying your goods in and out of the venue, please ensure that you are not dragging items across the floor. Any damage to the floor (i.e. scratching) will result in the stallholder having to pay for the re-surfacing of the floor.

**Garbage:** It is the stallholder's responsibility to take unsold items with them. Please leave your stall area the way you found it.

**Security:** No responsibility is taken by the organisers for theft, loss or damage (this also applies to large items). Stallholders are responsible for their own stall security and monies.

**Safety:** The stallholder is responsible for the safety for his table/ stall, i.e. setting items up in a safe & secure manner to avoid accidents.

**Refund policy:** We do not refund, sorry.

**Stall holders can sell:** Quality goods or services relating to babies, toddlers, and kids..

**Stall holders can not sell:** Anything unrelated to baby & kids and dangerous goods!

**Decorations:** Nothing can be placed against or hung, stuck, tapped, glued, nailed, screwed or in any other way attached to, affixed or placed upon any wall, door, curtain or any other portion of the building.

**Market cancellation:** Should a Baby & Kids Market be cancelled due to reasons of emergency, danger, weather conditions, disasters, safety, health concerns, or other reasons that are not in reasonable control of the Baby & Kids Market organisers (as judged by the Baby & Kids Market organisers), then stall holders will not receive a refund of their stall hire paid.

**Other:** The Baby & Kids Market shall not be responsible for the compliance by a stall holder with any By-law, Regulation, Act or Statute. There are guidelines about selling goods relating to children and babies. These guidelines can be found on the ACCC's website. ([www.accc.gov.au](http://www.accc.gov.au)) or by calling the ACCC on 1300 302 502. The Baby & Kids Market accepts no responsibility for any transaction entered into in the Market enclosure. The Baby & Kids Market will not refund stall hire fees paid in the case of cancellation of market due to factors out of our control. The Baby & Kids Market reserves the right to decide or arbitrate any dispute arising out of or in the course of the conduct of the Market. The Baby & Kids Market reserves the right to refuse admission to the Market to any person without giving any reason for the same and to eject or cause to be ejected any person and /or his/her goods and chattels without giving any reason for the same. The Baby & Kids Market accepts no liability for the loss or damage of any kind suffered by any person who enters the Market area and all persons who enter the Market area do so at their own risk. The stall holder agrees to indemnify the Baby & Kids Market against all claims for damages or injury to the property or person of any persons in respect of any claim by any such person arising out of negligence on the part of the stall holder or his agents or servants.
